Concise discussions or perspectives on recent legal developments, case laws or policy debates (1,500–2,500 words)

Submission Guidelines

All manuscripts must be original, unpublished, and not under simultaneous consideration elsewhere.

- *Submissions should be formatted in MS Word (.doc or .docx) using Times New Roman, 12-point font, 1.5 line spacing, and justified alignment.*
- *Manuscripts must include an abstract of 150–250 words and 4–6 keywords.*
- *Authors must adhere to a uniform citation style the ILI format.*
- *Submissions are accepted in English and Hindi only.*
- *Co-authorship is permissible up to a maximum of two authors.*
